1. The grant of recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond class VIII.
2. The School shall abide by the provisions Right of Children to Free and Compulsory Act-2009 and the Odisha Right to Children to Free and Compulsory Education Rules, 2010.
3. The School shall admit in class I, to extent of 25% of the strength of that class, Children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory Elementary Education till its completion.
4. For the Children referred to in paragraph 3, the School shall be reimbursed as per section 12(2) of the Act. To receive such Reimbursement School shall provide a separate Bank Account.
5. The Society/School shall not collect any captioned fee and subject the child or his or her parents or guardians to any screening procedure.
6. The School shall not deny admission to any child for lack of age proof. If such admission is sought subsequent to the extended/ provided/ prescribed for admission.  
On the ground of religion, cast or race, place of birth or any them.
7. The School shall ensure:
  - (i) No child admitted shall be held back in any class or expelled from school till the completion of Elementary Education in a school.
  - (ii) No child shall be subject to physical punishment or mental harassment.
  - (iii) No child is required to pass any board examination till the completion of Elementary Education.
  - (iv) Every child completing Elementary Education shall be awarded a certificate as laid down under Rule-22.
  - (v) Inclusion of Students with disabilities/special needs as per provision of Act.
  - (vi) The teacher are recruited with minimum qualifications as laid under Section12 (1) of the Act.
  - (vii) The teacher performs its duties Specified under Section24 (1) of the Act.
  - (viii) The teacher shall not engage themselves for private teaching activities.

8. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
9. The School enrolls students Proportionate to the facilities available in the school as prescribed in the Section 19 of the Act.
10. The School shall maintain the standards and norms of the School as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-



2. The school shall be opened to inspection by the Officers of S & ME Deptt. as and when required.
3. No Financial Assistance or any kind of Grant-in-Aid ( either recurring or non-recurring ) will be claimed by the institution from the Government at any point of time.
4. The High Power Committee shall be competent to review the NOC now granted to the institution concerned and shall be competent to withdraw the same on violation of terms and conditions laid down in Govt. Acts / Rules / Executive Instructions.
5. The Managing Committee shall be constituted in accordance with the Sec-7 of the Odisha Education Act-1969 as amended from time to time.
6. The school shall not be shifted from its present location without prior approval of Director, Secondary Education, Odisha.
